



## APPLICATION TO COMMUTE FROM HOME

All first and second year students at Rochester College are required to live on campus in the residence halls. Third and fourth year students have the opportunity to live in on-campus or off-campus. Please be aware that many scholarships are granted based on living on campus in the residence hall so check with Financial Services to ensure no loss of scholarship will occur if you choose to not reside on campus.

If a student desires to commute from the home of their parent(s) or legal guardian they need to complete and submit the following by July 31st for Fall or December 2<sup>nd</sup> for Spring Semester. Student Life will review the application and notify the student if approved.
